REDUCING GREENHOUSE GAS EMISSIONS

We are committed to reducing greenhouse gas emissions by promoting the efficient use of resources, including energy, water and materials. We systematically monitor our energy, water and waste consumption and implement measures to improve our environmental performance.

PROTECTING BIODIVERSITY AND NATURE

Our activities include reducing pollution, protecting the natural environment, and protecting animal and plant species. We pay special attention to preserving biodiversity in the Ukanc area, where we support grazing and prevent overgrowing of mountain pastures.

RESPECT FOR HUMAN RIGHTS

We ensure respect for fundamental human rights in accordance with the Universal Declaration of Human Rights. We pay particular attention to the protection of minorities, vulnerable groups (such as children, adolescents and women), and to the prevention of any form of violence, harassment or exploitation.

We do not tolerate any form of discrimination based on age, gender, race, religion or belief, disability, sexual orientation or any other personal circumstances. All employees have equal opportunities for employment, promotion, training and other employment rights.

ENVIRONMENTAL PERFORMANCE

ENERGY CONSUMPTION

Comparison:

2023:
41,050 kWh total – 12.1 kWh/guest night – 9.2 t CO₂e

2024:
38,920 kWh total – 11.3 kWh/guest night – 8.5 t CO₂e

What worked well:

Installation of LED lights and optimized guest communication contributed to lower energy consumption.

Recommended improvements:

Install smart sensors and continue guest education.

WATER CONSUMPTION

Comparison:

2023: 2,790 m³ – 0.82 m³/guest night

2024: 2,485 m³ – 0.72 m³/guest night

What worked well:

Information labels in rooms, improved guest instructions and low-flow shower heads.

Recommended improvements:

Install additional flow regulators and monitor per-chalet usage.

SOLID WASTE DISPOSAL

Comparison:

2023:
2,130 kg total (mixed), 1,120 kg recycled, 120 kg compost

2024:
1,960 kg total (mixed), 1,460 kg recycled, 150 kg compost

What worked well:

Color-coded labeling system and guest education improved separation.

Recommended improvements:

Continue improving kitchen workflows and composting options.

TOTAL EMISSIONS

2023: 9.2 t CO₂e / 2.72 kg CO₂e per guest night

2024: 8.5 t CO₂e / 2.47 kg CO₂e per guest night
